

## **Sale of shares in Nordax Group AB (publ)**

Vision Capital Partners VII LP (Guernsey LP) and Vision Capital Partners VII A LP (Guernsey LP) (together "Vision Capital"), have sold 15,000,000 shares in Nordax Group AB (publ) ("Nordax") through an accelerated bookbuilding to Swedish and international investors at a price of SEK 44 per share ("the placing").

Following the placing, Vision Capital owns 25,058,347 shares in Nordax corresponding to 22.6% of the total number of shares and votes (19,657,982 shares are held by Vision Capital Partners VII LP (Guernsey LP) and 5,400,365 shares are held by Vision Capital Partners VII A LP (Guernsey LP)).

Carnegie Investment Bank AB has acted as sole bookrunner in connection with the placing.
